Current issue campaigns include efforts to adopt city-wide systemic changes for police accountability and changes to immigration policies to protect the rights and dignity of immigrants on the city and state level.

4b (Code:) (Expenses \$ 142,431. including grants of \$) (Revenue \$ 27,750.) Youth Engagement: JCUA's summer immersion Teen Social Justice Institute and college-aged Organizing Fellows throughout the academic year help youth to: learn about social justice issues in Chicago from a root-cause perspective; build community organizing skills; develop as civically-engaged and compassionate youth leaders, and strengthen their Jewish identity. Youth are deeply involved in JCUA's campaigns and related issues.

4c (Code:) (Expenses \$ 106,603. including grants of \$) (Revenue \$) Community Investment: Through JCUA's zero-interest loan program, JCUA serves as a catalyst for strengthening communities through the creation and preservation of affordable housing. The loan fund also provides zero-interest resources for economic and community development projects. Individuals and financial institutions support JCUA's revolving loan fund, targeted primarily to pre-development costs.
